A complete set of Bidding Documents may be purchased from the Melamchi Municipality office, Melamchi, Sindhupalchowk by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, PAN Registration & Tax Clearance Certificate of 2072/73 and upon payment of a non-refundable fee of as specified above
- Sealed bids must be submitted to the Melamchi Municipality office by hand on or before as specified above Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at as specified above at the *Melamchi Municipality office*. Bidder's representative should come with authorization duly signed by the authority of firm at the time of bid opening.
- 7. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format.
- If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 1680300000003000004 (Ga-3) at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount of cash along with the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
- 11. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- 12. If there are any changes or correction in notice or on bid document, the notice will be published in Melamchi Municipality notice board.
- 13. Bid will open at Melamchi Municipality Office, Melamchi Sindhupalchok, Nepal.
- 14. Those owners whose firm or company was blacklisted earlier with the provisions of Public Procurement Act, 2007 and if they have commenced New Business in the name of new firm or company are not allowed to participate in the Bid Proceedings.
- 15. Other things not included in bidding documents will be as per PPA 2063 and PPR 2064.
