for the "CONSTRUCTION OF PHATAKSHILA WATER SUPPLY PROJECT(PHASE IV)"

1. Melamchi Municipality, office of the Municipal Executive invites electronic bids from eligible bidders for the construction of Phatakshila water supply project, under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 2,80,00,000.00
 - Minimum Work experience of similar size and nature: at least one Project and value of NRs 1,80,00,000.00.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

 4. A complete set of Bidding Documents may download from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document non-refundable fee of NRs 3,000.00 in the Project's Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held at Melamchi Municipality, Office of the Municipal Executive, Melamchi, Sindhupalchok at 2075/11/22 on 12:00 Hrs.
6. Electronic bids must be submitted to Melamchi Municipality, Office of the Municipal Executive, Melamchi, Sindhupalchok through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on 2075/12/4. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2075/12/4, 13:00 Hrs at Melamchi Municipality, Office of the Municipal Executive, Melamchi, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 4,80,000.00 which shall be valid for 30 days beyond the validity period of the bid i.e. 2076/3/2.
8. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 1680300000000300004(Ga-3) at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount along with the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
11. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
12. If there are any changes or correction in notice or on bid document, the notice will be published in Melamchi Municipality notice board & web page.
13. Bidder may get details of e-bid procedure from Public Procurement Monitoring Office (PPMO) at Tahachal, Kathmandu Nepal.
14. Other things not included in bidding documents will be as per PPA, 2063 and PPR, 2064.
