1. Melamchi Municipality, office of the Municipal Executive invites electronic bids from eligible bidders for the construction of Melamchi Municipality office Building, under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 3,00,00,000.00**
 - Minimum Work experience of similar size and nature: at least **one project and value of NRs 2,70,00,000.00**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2075/9/4, 13:00 Hrs** at Melamchi Municipality, office of the Municipal Executive, Melamchi Sindhupalchok Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **7,00,000.00** which shall be valid for 30 days beyond the validity period of the bid i.e **2076/1/15**.
8. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 16803000000003000004 (Ga-3) at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount along with the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
11. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
12. If there are any changes or correction in notice or on bid document, the notice will be published in Melamchi Municipality notice board & web page.
