1. **Melamchi Municipality, Office of the Municipal Executive** invites sealed bids or electronic bids from Nepalese eligible bidders for the "**ROAD IMPROVEMENT WORK ALONG MELAMCHI MUNICIPALITY OFFICE BUILDING TOWARDS HELAMBU ROAD**" under National Competitive Bidding procedures. The estimated amount for the works is Rs. 75,00,000.00

A complete set of Bidding Documents may be purchased from the office **Melamchi Municipality, Office of the Municipal Executive** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **3000.00** till **2076/1/8** during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

4. Pre-bid meeting shall not be held.
5. Sealed or electronic bids must be submitted to the office **Melamchi Municipality, Office of the Municipal Executive** by hand or through PPMO website www.bolpatra.gov.np/egp on or before **12:00** on **2076/1/09**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2076/1/09** at the office of **Melamchi Municipality, Office of the Municipal Executive** . Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of 1,90,000.00 , which shall be valid for 30 days beyond the validity period of the bid.
7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 1680300000003000004 (Ga-3) at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
