However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

4. Pre-bid meeting shall be held at Melamchi Municipality, office of the Municipal Executive, Melamchi Sindhupalchok at 2076/1/10, and 12:00 Noon.
5. Sealed or electronic bids must be submitted to the office Melamchi Municipality, office of the Municipal Executive, Melamchi Sindhupalchok by hand/courier or through PPMO website www.bolpatra.gov.np. on or before 12:00 on 2076/1/20. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00, 2076/1/20 at the office of Melamchi Municipality, office of the Municipal Executive, Melamchi Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 4, 00,000.00 which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 1680300000003000004 (Ga-3) at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount along with the bid.
