Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost as specified above of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting Shall be held at Melamchi Municipality office on 2074/1/14 at 14:00 PM.
5. Sealed bids must be submitted to the Melamchi Municipality office by hand or Electronic bids must be submitted through the PPMO website www.bolpatra.gov.np on or before as specified above. Bids received after this deadline will be rejected.
6. The bid will be opened in the presence of Bidders' representatives who choose to attend at as specified above at the Melamchi Municipality office. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format. In case of e-bid, amounting to a minimum of as specified above, which shall be valid for 30 days beyond the validity period of the bid i.e. 2074/ 4 / 22 .
7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 1680300000000000300 at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount of cash along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain same as specified for the original last date of bid submission.
9. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
11. If there are any changes or correction in notice or on bid document, the notice will be published in Melamchi Municipality notice board.
12. Bidder may get details of e-bid procedures from Public Procurement Monitoring Office (PPMO) at Tahachal, Kathmandu Nepal.
13. Bid will be opened at Melamchi Municipality Office, MelamchiSindhupalchok, Nepal.
14. In case of two envelope bidding, The Bid shall comprise two sealed envelopes submitted simultaneously, one called the Technical Bid and other the Price Bid containing the both envelopes enclosed together in an outer single sealed envelope.
