Bidders, submitting their bid electronically, should deposit the cost as specified above of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

4. Pre-bid meeting Shall be held at Melamchi Municipality office.
5. Sealed bids must be submitted to the Melamchi Municipality office by hand or Electronic bids must be submitted to the through PPMO website **www.bolpatra.gov.np**, on or before as specified above Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at as specified above at the Melamchi Municipality office. Bids must be valid for a period of 90 days after bid opening and must accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as specified above, which shall be valid for 30 days beyond the validity period of the bid.
7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit **Account No: 16803000000003000004(Ga-3)** at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
11. If there are any changes or correction in notice or on bid document, the notice will be published in Melamchi Municipality notice board.
12. Bidder may get details of e-bid procedure from Public Procurement Monitoring Office (PPMO) at Tahachal, Kathmandu Nepal.
13. Bid will open at Melamchi Municipality Office, Melamchi, Sindhupalchok, Nepal.
