- 4. Pre-bid meeting Shall be held at Melamchi Municipality office.
- 5. Sealed bids must be submitted to the Melamchi Municipality office by hand or Electronic bids must be submitted to the through PPMO website **www.bolpatra.gov.np.** on or before as specified above Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at as specified above at the Melamchi Municipality office. Bids must be valid for a period of 90 days after bid opening and must accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as specified above, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
- 10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
